## **GENERAL DESCRIPTION**

Pursuant to Fla. Statute 28.211, the Clerk's Office maintains various name index files containing an alphabetical index, direct and inverse, of party names for all cases.

Sealed and/or confidential cases will not be published in these name indexes based on Florida Statutes and Florida Rules of General Practice and Judicial Administration.

Examples include, but not limited to, Juvenile Delinquency and Dependency, and Adoption.

Separate name index files are created for each of the following court types:

Circuit Civil Family Law Circuit Criminal Criminal Traffic County Civil Probate County Criminal Civil Traffic

Name indexes are provided in alphanumeric and year format.

Alphanumeric names are grouped by the first letter of the party's last name resulting in 26 alphabetical files. One additional file is provided for non-alphabetical values.

The year files are created based on the year of case being filed.

Files are in pipe delimited format and contain column headings. No value will be displayed between the respective pipe fields for confidential or null values.

Date format is MM/DD/YYYY.
